ARTICLES OF INCORPORATION OF SCHUYLKILL RIVER PASSENGER RAIL AUTHORITY

TO THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA:

In compliance with the requirements with the Act of May 2, 1945, P.L. 382, known as the "Municipality Authorities Act of 1945", 53 Pa.C.S.A., §5601, et seq., as amended, supplemented, modified and/or reenacted, by the General Assembly of the Commonwealth of Pennsylvania ("Act"), Berks County, Pennsylvania ("Berks County"), Chester County, Pennsylvania ("Chester County"), and Montgomery County, Pennsylvania ("Montgomery County"), expressing their intention and desire to organize and incorporate an Authority under the Act does hereby certify:

- 1. The name of the Authority is: Schuylkill River Passenger Rail Authority ("Authority").
