Q31 Any additional comments.

Representative comments are provided below, in order of submission. 94 comments were submitted. Comments were generally supportive of preservation, but the range of comments included submissions such as: opposed to additional tax dollars for preservation; discussion of specific parcels; discussion of areas where growth should be directed; discussion of specific points on open space, natural resources, or historic resources; and offers of assistance in the development of Landscapes3 or more broadly on preservation issues.

Representative Comments Submitted:

I think the county is putting too many resources into open space and land preservation, instead of improving our roads, and revitalizing communities like Coatesville, Parkesburg, Oxford, Spring City, etc...

Land preservation policies should be extremely active in discouraging development of rural land, and directing growth instead into our urban centers.

I am ready and willing to pay a tax specifically earmarked to purchase properties or development rights to retain the land as open space.

A large part of Chester County's appeal is that we have open space, farmland, & outdoor recreational opportunities.

More public transportation is needed.

The beautiful landscape of Chester County is why the area is so desirable to live and visit.

Preservation of historic properties and open space throughout Chester County needs to be a priority issue for our community and elected officials at the local, county, state and federal levels. We cannot allow overdevelopment and misuse of natural resources denigrate our beautiful county. Take action now to keep Chester County beautiful.

I'm a Fifth generation Chester Countian and I am saddened by the greed of developers exploiting the lack of coordination and oversight by municipalities. We need re-use and revitalization more than the destruction of farmland. As we lose our connection to the agrarian roots we cherish in chesco - we lose our dignity as a community.

Mechanisms should be created by the local government to ease the expense and difficulty of maintaining and restoring Historic Resources for the private owner (e.g., very low interest loans, identification of quality contractors with experience in working on older structures).

I have become very concerned with the quality of the water and air in our region. Preservation of our land and restoration of our water quality is very important to my family.

Emphasis should be on conservation and restoration, not just preservation. Emphasize linkages between blocks of protected land.

Please continue to strengthen Chester County's leadership in addressing climate change - it is a top threat that impacts our security, economy, and environment, and needs to be addressed at all levels of society.

I think enough has been spent on open space. Not "all citizens" benefit. But all pay the tax.

Natural resources need to be valued for the services they provide. The growth forecasts for this area are not to be taken lightly and appropriate planning is not currently in place.

As development pressures continue to impact our communities, it is vital that we devote necessary resources to the very assets that make Chester County one of the most desirable places to live on the east coast. I trust that our county officials and local legislators will continue to protect our incredible landscape and our rich history.

Not enough training done for historic commissions and HARB members who don't always realize the consequences of their rulings and actions.

I do not think any additional taxpayer money should be used for open space.

The county needs to encourage development in the small towns like Oxford, Kennett Square, West Grove, etc. and not along the Rt. 1 corridor.

Efforts in Chester County should include a focus on natural resource preservation AND an increased focus on natural resource restoration.
